## Important Schedule Notes

- Starting times listed for examinations refer to local time except for Exam 5, which is using a technology-based examination environment. For Exam 5, candidates will schedule their individual start time with PSI, the remote proctoring vendor.
- Exam 5 is developed to be a four-hour exam; however, candidates will have five hours to take the exam in the TBE environment. The clock starts after the check-in process, when the remote proctor releases the exam.
- Candidates should arrive at the examination center at least 30 minutes prior to the scheduled exam time for the check-in process. For Exam 5, candidates should start the check-in process up to thirty minutes before the scheduled start of their examination.
- For Exams MAS I, MAS II, and 6-9, there will be a 15-minute reading period prior to the commencement of the timed exams. Exam 5 will not have a reading period.
- Waivers for Exam 1, Exam 2, Exam 3F, and Exam 4 are accepted from the Actuarial Society of South Africa, the Actuaries Institute (Australia), the Canadian Institute of Actuaries (except for Exam 1), the Institute and Faculty of Actuaries, and the Society of Actuaries. In addition, the CAS will grant exam waivers based on exams administered by the China Association of Actuaries as a cohort for CAS Exams 1, 2, and 3F, CAS Exam 4 (prior to July 1, 2018), and Validation by Educational Experience requirements -- Corporate Finance (Accounting and Finance subsequent to July 1, 2018) and Economics. Updated information for waivers for Exam 1, Exam 2, Exam 3F, and Exam 4 will be incorporated as necessary and will be noted in the *Syllabus* section for the specific exam. - To meet the CAS requirements for CERA, candidates should submit their registration to the CAS for Institute and Faculty of Actuaries (U.K.) Exam ST9.
