RE:	Changes for the Fall 2021 CAS Syllabus of Basic Education

The CAS has approved the following changes for the Fall 2021 syllabus. Other changes that may be made include modifications to Learning Objectives and Knowledge Statements, as well as edition changes to current citations.

The Fall 2021 syllabus will be posted in May 2021 and the CAS Study Kits will be available June 2021. Candidates should be guided by the *Syllabus of Basic Education* for the **final** Learning Objectives, Knowledge Statements, and Text References for each examination and to not rely solely on the advanced notice provided in this memorandum.

### Exam 6-Canada
