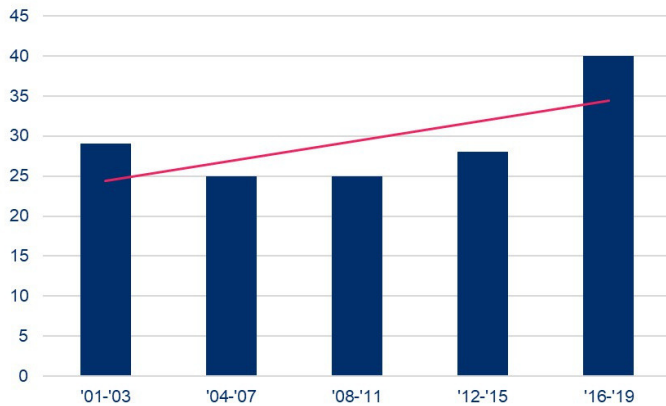
Antitrust Notice

Healthcare Professional Liability - Large Loss Data Points

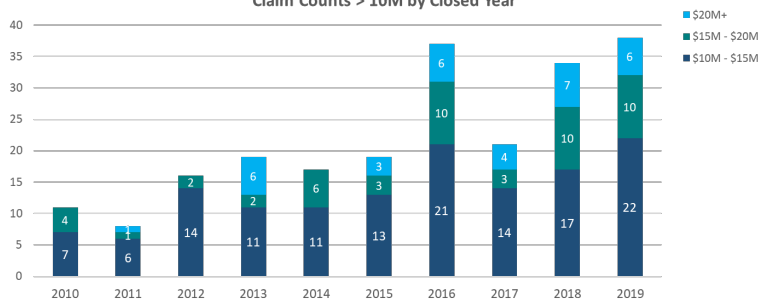
\$10 Million Plus HPL Verdicts
