# CAS CERA designation background

- 2007: SOA announces plans to offer CERA designation
- 2008-2009: CAS ERM Designation Task Force weighs ERM options
- 2009: CERA Global Association formed
- 2010: CAS applies for CERA Award Signatory status
- 2011: CAS adopts ST9, becomes CERA Award Signatory
- 2012: First ERMM seminars offered, CAS members sit for ST9
- ? CAS announces CERA qualifying exam



## CAS CERA facts

- 146 CAS members awarded CERA designation
  - 38 under SOA Experienced Practitioner Pathway
  - 13 via examination (through fall, 2012 sitting)
  - 95 via CAS Experienced Practitioner Pathway
- 103 CAS members have attended ERMM seminar for CERA
- 67 CAS members have sat for ST9 exam (through April, 2013 sitting)
- Comparative ST9 exam statistics

# Considerations in development of CAS CERA exam

- CERA learning objectives adequately covered and tested
  - Trend towards combination of exam(s) and seminar(s)
  - Preference for exam(s) with predominately ERM content
- CERA syllabus vis-à-vis overall CAS syllabus
  - ERM material incorporated across several CAS exams and online courses
  - Balancing CERA requirements against objective for wide exposure to ERM requires CAS to manage the degree of overlap
- Style of examination to satisfy CERA Global Association requirements
  - Preference for exams testing higher order thinking, synthesis of knowledge
  - Fewer questions, higher point values
  - Higher Bloom's taxonomy rating
